




120 requests submitted

- 104 requests are on-going




In which thematic areas is support being requested?


Who is requesting Support?


Where are requests coming from?

Cross-cutting themes workstreams



Cross-cutting Themes (CCT) workstreams were established this quarter. Their purpose is to develop a common approach to mainstream them into NiE coordination and programming. This includes designating focal persons to handle support requests, mapping and collating guidance for these themes, and sharing the most practical and simple tools to assist country practitioners in their mainstreaming within NiE programs and coordination mechanisms.

The following workstreams were established:

- Anti-racism and Localization
- Gender & GBV
- Disability
- Humanitarian Development Nexus (HDN)
- Accountability to affected populations (AAP)
- Climate change

The focus of this quarter was for each group to develop its ToR and an annual work plan.

7 Partners are engaged in the CCT workstreams in addition to Alliance core agencies with 53 members across the 6 Groups

Communications & Knowledge Management



Webinars:

- 1 webinar took place: "Lessons learned from piloting different simplified approaches (for managing malnutrition) in DRC"
- This was attended by 179 participants, 80 (45%) were from local NGOs
- The webinar workstream was established this quarter with 7 members. The group developed its ToR and an annual work plan

Learning Needs & Products

- This quarter work continues a learning piece on the use of MUAC and WHZ classification, and Yemen NIS Taskforce evaluation
- The brief and podcast of "<u>How local NGOs receive technical support from the Alliance</u>" were released

Thought Leadership Updates



- The IFE Core Group rapidly shifted Workplan activities to answer 15 technical requests related to the Ukraine nutrition response.
 - 2 working groups were established to explore programmatic needs and advocacy-related needs to support partners in Ukraine and surrounding countries.
- The Wasting GTWG finalized an information note on programming in the absence of therapeutic products.
- A focus within the NIS GTWG was on supporting Yemen country partners in preparing for and conducting an IPC AMN analysis.

Thought Leadership Updates



- •A focus within the NIS GTWG was on supporting Yemen country partners in preparing for and conducting an IPC AMN analysis.
- The Nutrition & CVA GTWG continued to work on a mapping exercise led by a team of consultants with a desk review of 72 papers and 27 KI interviews conducted during the quarter.
- •A fourth cross-chair quarterly call was set up to explore areas of collaboration across the GTWGs and processes for identifying technical gaps.
- •The Nutrition Guidance in Ebola Treatment Units Taskforce held one meeting in the quarter.
