On the <u>Nutrition Information Management Learning channel</u>, you will find a large collection of nutrition information management e-learning resources to suit all your learning needs. The modules and short courses featured on this channel are open-access and aim to strengthen the capacity of individuals, groups, and organisations in the management of nutrition information in humanitarian contexts. Learning has been organised around the six functional competencies of the <u>Information Management</u> <u>Competency Framework</u>. With a few exceptions, all modules are available in <u>English</u>, <u>French and Spanish</u>.
